PROGRAMME STRUCTURE

A sustainable approach to finance entails a critical rethinking of almost every discipline within our industry. The Executive Programme in ESG addresses this imperative by looking at banking and finance from the "ground up", reviewing the foundations of how we operate, our assumptions and views of markets, forecasting, risk, credit, investment and more.

The programme analyses environmental, social and governance (ESG) considerations, current thinking on taxonomy and regulation and how to develop both theoretical and applied perspectives.

PROGRAMME MODULES

The programme is delivered over three modules, each of twelve weeks, with the second and third module taking a deep dive into sustainability issues.



Financial Markets, Institutions, and Instruments

Module 1 provides in-depth knowledge of key concepts and theories of financial markets, institutions, and instruments, including their structure, functions, and their role in the socioeconomic environment and resource allocation.

PROGRAMME DESIGN

ASSESSMENTS

Provisions for local and distance support will be provided by academics and support teams even during the periods where there is no face-to-face sessions. PREREOUISITES

The programme is suitable for candidates holding positions up to a senior management level within the financial sector. This programme leads to further understanding for bankers, insurers, investment managers, central bankers and regulators, risk managers, analysts and consultants in their roles towards a sustainable future. Participants are required to hold a bachelor degree.

It may also be possible for a participant to be assessed through an interview/internal assessment. We encourage participants to speak to our admissions team with any questions on eligibility.

AWARDS

Participants that successfully complete the programme will receive a 60 credit Postgraduate Certificate Banking and Sustainable Finance, as well as a Certificate of Completion for Executive Programme in ESG.

Upon successful completion of the postgraduate certificate, graduates can proceed to study further taught modules and complete a dissertation to be awarded the MSc Banking and Sustainable Finance. *Additional cost is applicable
