UPON the companies listed above being placed into Administration on 27 September 2020 at 18.24 GST (the **Companies and the Administrations**).

UPON READING the unissued application by Richard Fleming and Ben Cairns of Alvarez & Marsal as administrators of the Companies (the **Joint Administrators**) made pursuant to section 109A(2) of the Insolvency Regulations 2015 (as amended by the Insolvency (Amendment No.4) Regulations 2020) (**IR15 and the Application**), which application the Joint Administrators undertook to the Court to issue forthwith following the hearing of that unissued application.

UPON HEARING Felicity Toubé QC, Adam Al-Attar and Matthew Abraham (for the Joint Administrators) and David Wolfson QC and Andrew Rose (for the Commercial Bank of Dubai).

UPON READING the signed evidence of Richard Fleming dated 19 September 2020 and Romain Lanier dated 19 September 2020.

UPON the Joint Administrators, through leading counsel, undertaking to file the Application and pay the appropriate fees following the making of this order.

UPON the Court being satisfied that the Joint Administrators have been unable to obtain unsecured credit in accordance with section 109A(1) IR15.

UPON the Court being satisfied that, in the circumstances, it is appropriate for the Joint Administrators to enter into the administration financing entered into on 27 September 2020, comprising the following documents: (i) the Common Terms Agreement, (ii) the Commercial Facilities Agreement, (iii) the Master Murabaha Agreement, (iv) the Investment Agency Agreement and (v) the Islamic Rolled Up Facility

Undertaking Agreement, between, among others, NMC Healthcare LTD (in administration), the Joint Administrators (in their capacity as Joint Administrators of the Companies) and Abu Dhabi Commercial Bank PJSC as Facility Agent (the **AFF**).



AND UPON the Court being satisfied that the **AFF**, as described to the Court in the evidence, is necessary and appropriate for the achievement of the purposes of the Administrations.

AND UPON the Joint Administrators, through their counsel, undertaking to file evidence: (1) exhibiting the signed **AFF**; (2) confirming that the lenders underwriting the **AFF** have stated during the course of the hearing that they would not provide finance for a lesser amount to cover the immediate cash needs of the Companies; and (3) confirming that the only preferential creditors would be employees, whose wages are at least typically up to date or at least would be in an administration.

IT IS DIRECTED AND ORDERED THAT:

1. Pursuant to s.109A(2) IR15, the Joint Administrators are permitted, irrespective of prior rights and prohibitions to the contrary, to obtain credit or incur debt, on the terms set out in the **AFF**.
2. The costs of the Application be treated as an expense in the Administrations with priority over all other expenses of the administration within the meaning of section 109A(2)(a) on an equal basis for each of the Companies save for those expenses in ss.107(1)(a), (c), (f), (g), and (h) IR15.
