## EXECUTIVE SUMMARY:

The UAE Cyber Security Council has observed multiple vulnerabilities in NetApp products that attackers could potentially exploit, leading to severe consequences such as remote code execution, denial of service, data breaches, and unauthorized access to affected systems.

## TECHNICAL DETAILS:

### Critical- Severity Vulnerabilities:

- CVE-2024-56337 Apache Tomcat Vulnerability in NetApp Products
- CVE-2024-53677 Apache Struts Vulnerability in NetApp Products
- CVE-2024-52046 Apache MINA Vulnerability in NetApp Products
- CVE-2024-50379 Apache Tomcat Vulnerability in NetApp Products
- CVE-2023-38429 Linux Kernel Vulnerability in NetApp Products
- CVE-2017-18017 Linux Kernel Vulnerability in NetApp Products
- CVE-2016-10229 Linux Kernel Vulnerability in NetApp Products

### High-Severity Vulnerabilities:

- CVE-2024-49767 Werkzeug Vulnerability in NetApp Products
- CVE-2024-45802 Squid Vulnerability in NetApp Products

Successful exploitation of these vulnerabilities could potentially lead to:

- Remote code execution
- Denial of service
- Information disclosure
- Unauthorized access to affected systems
- Data manipulation

**Note:** Refer to NetApp advisories for affected products, mitigations and more information.

## RECOMMENDATIONS:

The UAE Cyber Security Council recommends applying the mitigation or workaround provided by NetApp.

**Apply Patches:** As soon as patches or updates become available, apply them to all affected systems. Prioritize applying patches for critical severity vulnerabilities.

Kindly circulate this information to your subsidiaries and partners as well as share with us any relevant information and findings.
