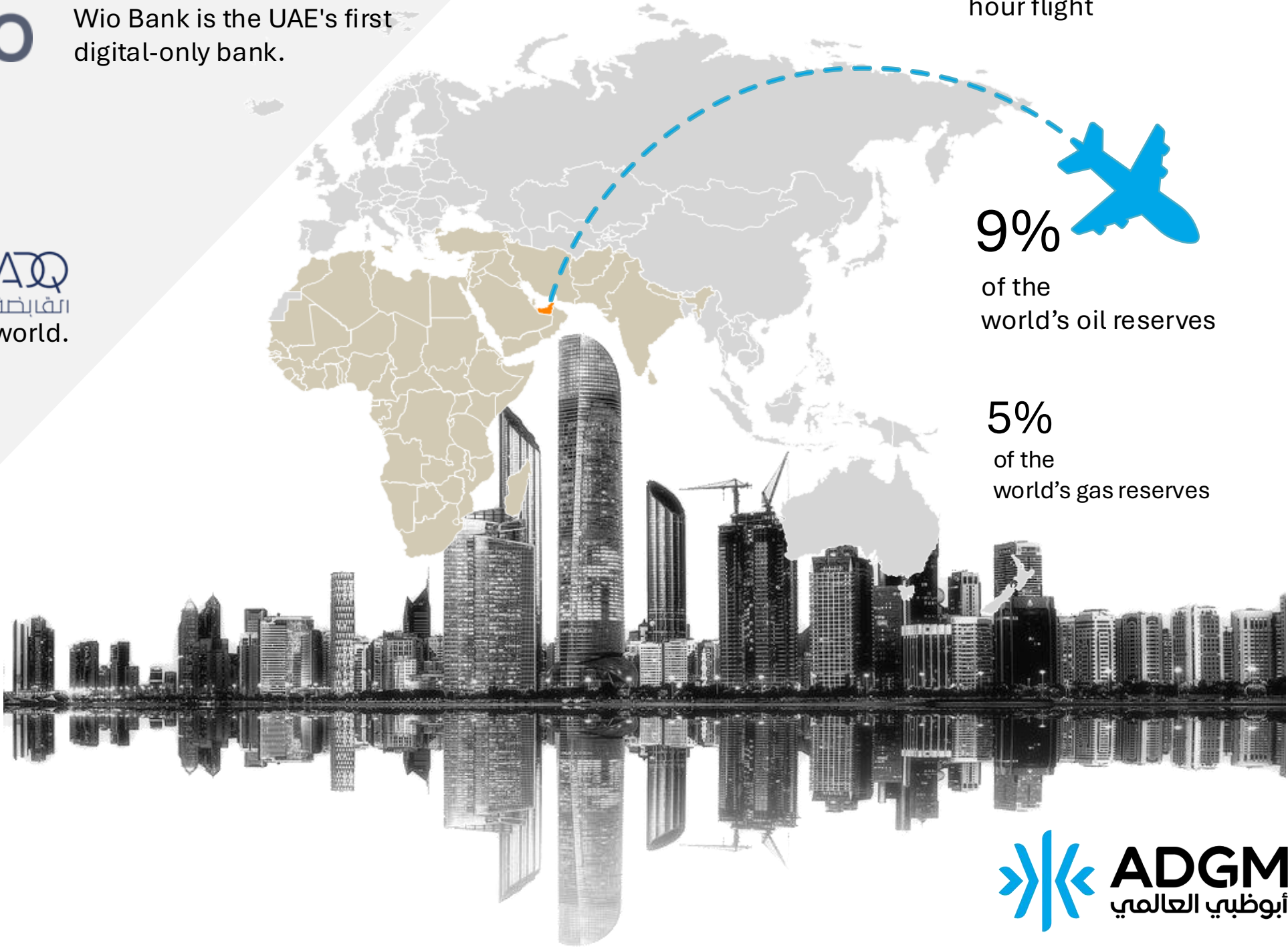

- First jurisdiction in the Middle East to directly apply English Common Law.



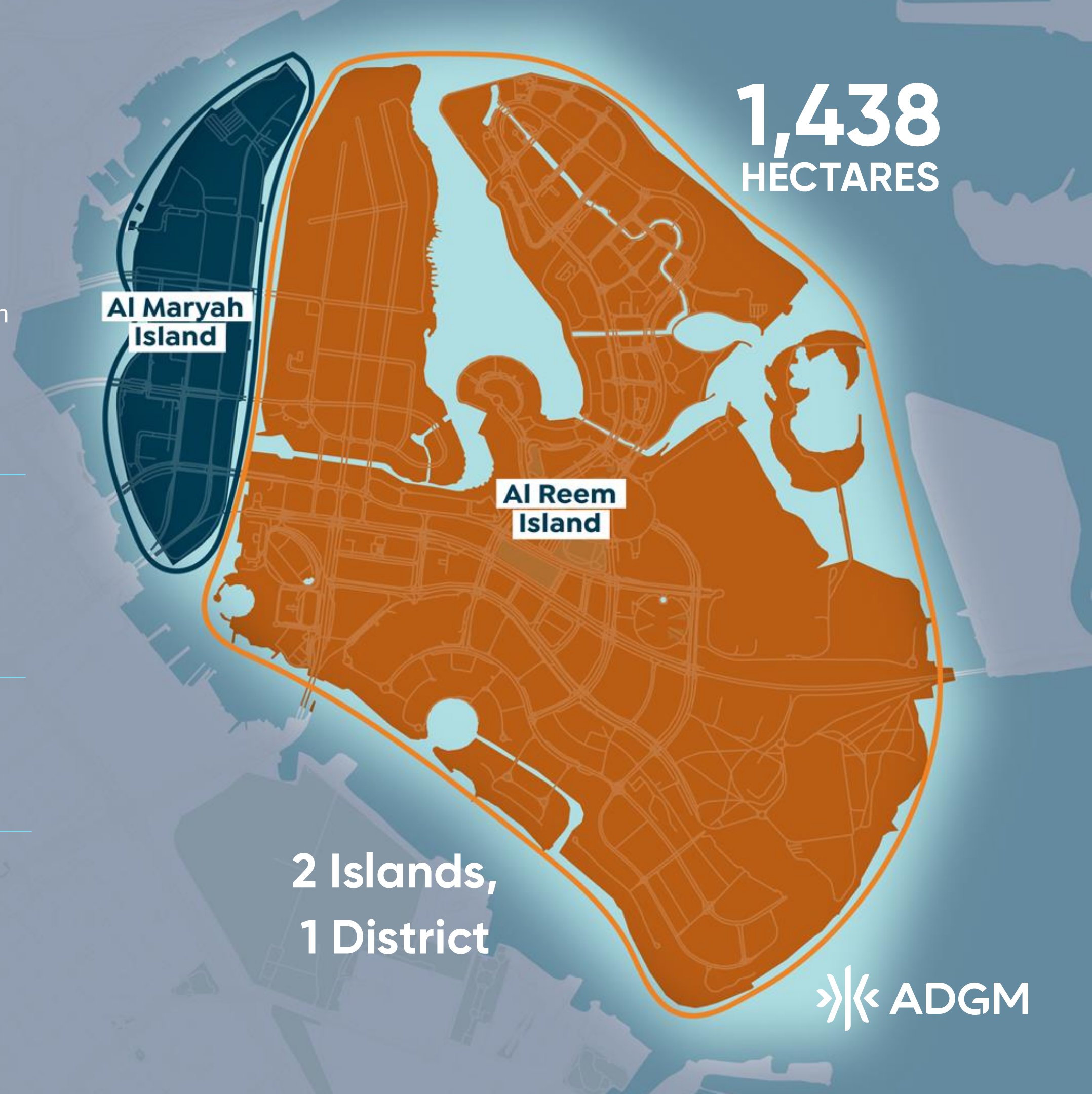

Access to premium schools through Aldar network (including Repton, Nord Anglia, Sorbonne University, Cranleigh, Pearl Academy, Al Mamoura)



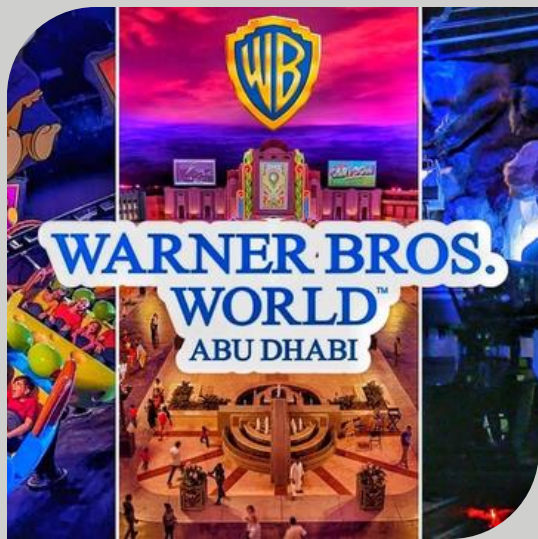

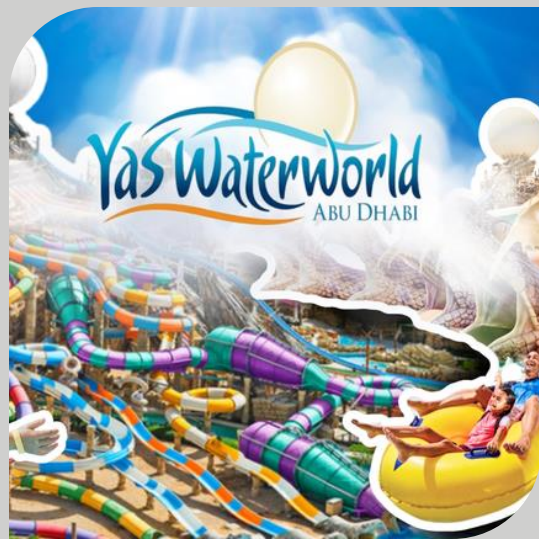

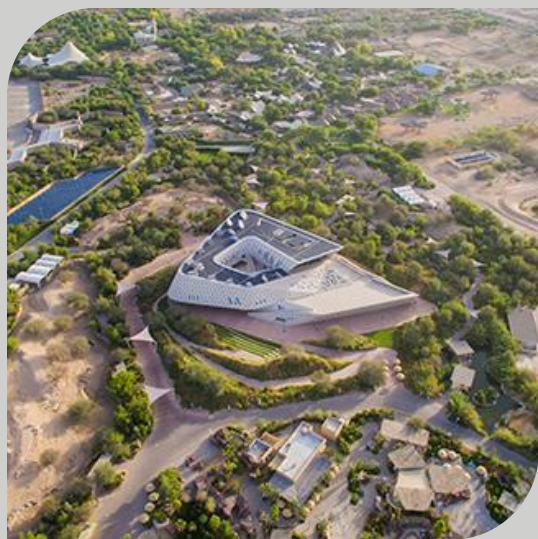
