UPON reading the Claim filed on 6 June 2022 (including the witness statement of Mr. Nils de Wolff dated 18 May 2022 in support, and the exhibits attached thereto) (the “**Claim**”) in which the Claimant has applied for an order to restore First Fund Management Limited (000001219) (the “**Company**”) to the ADGM Register of Companies (the “**Register**”) pursuant to section 887(1)(c)(ii) of the ADGM Companies Regulations 2020 (the “**Regulations**”)

AND UPON reading the letter from Squire Patton Boggs (MEA) LLP dated 7 July 2022 in which the Defendant has confirmed that it does not intend to contest the Claim and will comply with its obligations under sections 889(2)-(4) of the Regulations if the application is granted, however it intends to recover its costs in connection with the Claim in accordance with section 890(4)(b) of the Regulations

IT IS HEREBY ORDERED AND DIRECTED THAT:

1. The Company is to be restored to the Register pursuant to section 889(1)(d) of the Regulations.
2. The Claimant is to deliver a copy of this Order to the ADGM Registrar of Companies (the “**Registrar**”) by email to ra.courtsservice@adgm.com by no later than **19 July 2022**, at which time the restoration of the Company takes effect pursuant to section 889(2) of the Regulations.
3. The Claimant shall notify the Court Registry by no later than **19 July 2022** that this Order has been delivered to the Registrar in accordance with paragraph 2 of this Order.



4. Pursuant to sections 889(3)-(4) of the Regulations, the Registrar must cause to be published on the website of the Registrar notice of the restoration of the Company to the Register.
5. Pursuant to section 890(4)(b) of the Regulations, and failing any agreement reached between the parties as to the payment of the costs of the Registrar in connection with the proceedings,;
 - a. the Defendant shall file and serve a statement of the costs of the Registrar in connection with these proceedings, such statement to include full details of the basis and amount for each cost item claimed, by no later than **4.00 pm on 26 July 2022**; and
 - b. the Claimant shall file and serve any response to the Registrar's statement of costs by no later than **4.00 pm on 2 August 2022**.
6. Liberty to apply.
