PROGRAMME STRUCTURE

A sustainable approach to finance entails a critical rethinking of almost every discipline within our industry. The Certificate in Sustainable Finance addresses this imperative by looking at banking and finance from the "ground up", reviewing the foundations of how we operate, our assumptions and views of markets, forecasting, risk, credit, investment and more.

The programme analyses environmental, social and governance considerations, current thinking on taxonomy and regulation and how to develop both theoretical and applied perspectives.

PROGRAMME MODULES

The programme is delivered over three modules, each of eight weeks, with the third module taking a deep dive into sustainability issues.

Principles of Banking & Finance

The core principles of banking and finance are re-examined through the lens of sustainable finance.

- Overview of banking institutions, markets and financial instruments.
- Introduction to derivatives including forward, futures, options and credit default swaps.

Markets & Risk

Markets and risk are taught and assessed with consideration of how they can be utilised differently to further sustainable goals.

- Understanding of various securities and issuance.
- Evaluating financial instruments and understanding risk management.
- Overview of financial transactions including end users and the impact of financial decision making.

Sustainable Finance

The principles taught during the first two modules are re-examined as sustainability is analysed at a deeper level.

- Understanding how Sustainable Finance works from an organisational perspective.
- Impact on decision-making and reporting in the context of environmental, social, cultural and governance perspectives.

Programme Design

Participants are required to hold a bachelor degree.

It may also be possible for a participant to be assessed through an interview/internal assessment. We encourage participants to speak to our admissions team with any questions on eligibility.
