# GUIDANCE ON CORPORATE SERVICES (COS)





# **Corporate Services**

# Description:

Corporate services are generic services that can be requested by ADGM-registered entities. The information provided in the certificates is based on the information kept by the Registration Authority ('RA') for the entity.

# Certified True Copies

The RA can certify a document related to the company, such as resolutions and registers, as a true copy. A copy of such documents should be uploaded with the request. On submission of the company's request, RA will verify that the document is related to the company. The stamped document stating that it is certified as an electronically filed document will be emailed to the authorized user who filed the request along with the email address nominated by the authorized user.

If the company would like a certified true copy of its constitutional documents, (i.e. Certificate of Incorporation/Registration/Change of Name, Articles of Association, Commercial License, etc.), the RA will certify the company's constitutional documents that are in the file. The certified true copy of the documents will be issued electronically and can be received instantly once the request is submitted.

The RA also issues the following certificates upon request:

Certificate of Incumbency	This certificate is issued electronically and can be received instantly once the request is submitted.  This certificate includes the following information about the company.  Registered Office Address  List of Directors and appointment date  List of Secretaries and appointment date (if applicable)  Number of issued shares  List of Shareholders and the effective date of becoming a shareholder  The Certificate of Incumbency does not include details of the company's share capital, number of shares, and ownership percentage that is being held by the shareholders. If the company wishes to have this information certified by RA, the company can request a certified true copy of its register of shareholders.
Certificate of Good Standing	The certificate is issued electronically and can be received instantly once the request is submitted. The companies should ensure that they are active and did not apply for deregistration/strike off or is not under liquidation. Additionally, the company's license is valid, and if



	applicable, the confirmation statement and annual account are submitted.
Under Formation Certificate	Applicants who submitted a Business Application or Application for Incorporation/Registration can apply for Under Formation Certificate. This document is issued electronically and can be received instantly once the request is submitted
Zero Tax Certificate	This certificate confirms the entity is subject to zero tax. This document is issued electronically and can be received instantly once the request is submitted.

# No Objection Certificates (NOCs)

The RA can issue the following NOCs upon request.

NOC to own/hold shares	The RA can issue a letter stating that the RA does not have any objection to the company owning or holding shares in entities registered in a jurisdiction outside ADGM. Companies registered in ADGM including SPVs and Techstartups but excluding branches can request this letter.
NOC to own a property	Companies who wish to buy properties that require registration with Abu Dhabi Municipality or Dubai Land Department would be asked by the said authorities to provide a letter issued by the RA. The RA can issue a letter stating that the RA does not have any objection to the company owning properties. Companies registered in ADGM including SPVs and Tech-startups but excluding branches can request this letter.
NOC – Dual License	Operational entities (except retailers) who wish to have a branch in Abu Dhabi onshore and use their office in ADGM as its registered office address can register their branch via the dual license regime. RA can issue such NOC to the entities. This NOC will be part of the entity's application to the Abu Dhabi Department of Economic Development.
NOC – Dual License Renewal	RA can issue such NOC for license renewal upon request. This is applicable for operational entities that registered a branch with the Abu Dhabi Department of Economic Development under the dual licensing regime.
Notary Pack	Companies who wish to notarize a document with the ADGM Notary Public may be required to provide to the Notary Public a certified true copy of the resolution (or similar documents) that supports the notarization and a Notary Pack. Notary Pack includes i) a declaration letter from RA and ii) a letter stating the powers of the directors under the ADGM Companies Regulations. The company can file a separate



request for the certified true copy and follow the steps below to request
the Notary Pack.
