Introduction

This document provides an overview of the fees currently applicable for services offered by the Registration Authority of ADGM. All fees specified in this schedule are in US dollars (unless otherwise specified).

Available Payment Methods

Credit Card Payment

We recommend that payments are made to the Registration Authority using our secure credit card facility within the Online Registry Solution. You will be prompted to make a payment once you have completed the required fields in an application. Currently only Visa and Mastercard are accepted through the [Online Registry Solution](#).

Bank Transfer

Should an organisation wish to use the Bank Transfer facility to make payments for services, please adhere to the following guidelines to avoid any delay in processing your application.

1. When completing the transfer, where possible please include within the reference for payment field:
 - Company name (of applicant)
 - Service that is being applied for
 - Once the transaction has been completed, please inform a member of the Registration Authority that this transfer has been successful, and if possible, provide a copy of the receipt of transfer.
 - Inform our accounts receivables team of the payment including details of the service paid for (AccountsReceivables@adgm.com)

The Registration Authority will not commence processing of any application until such time that payment has been successful and received within the account. By following the above steps, any potential delays in tracing payments may be avoided.

Types of Entities

The following types of legal persons and arrangements (entity types) are available within ADGM:

Entity Type	Legal Form	Description
Company	Public Company Limited by Shares	A company that has share capital and the liability of each member of the company is limited to the amount unpaid on their shares. A public company may offer shares for sale to the general public and may be quoted on a stock exchange.
	Private Company Limited by Shares	A company that has share capital and the liability of each member of the company is limited to the amount, if any, unpaid on their shares. As a private company, it cannot offer its shares for sale to the general public.
	Private Company Limited by Guarantee	A company that does not have a share capital and whose members are guarantors rather than shareholders. The liability of each member of the company is limited to the amount they agree to contribute to the company's assets if it is wound up. As a private company, it cannot offer its shares for sale to the general public.
	Private Company Unlimited with Shares	A company that has share capital and the liability of each member of the company is unlimited. As a private company, it cannot offer its shares for sale to the general public.
	Private Company Unlimited without Shares	A company that does not have share capital and the liability of each member of the company is unlimited. As a private company, it cannot offer its shares for sale to the general public.
	Protected Cell Company	A corporate structure in which a single legal entity is comprised of a core and several cells that have separate assets and liabilities. Each cell is independent of each other and of the company's core, but the entire unit is a single legal entity.
	Incorporated Cell Company	A corporate structure comprised of a core and several cells where each cell is incorporated as a separate legal entity (an Incorporated Cell).
	Incorporated Cell	A Public Company Limited by Shares, Private Company Limited by Shares or Private Company Unlimited with Shares which is the cell of an Incorporated Cell Company.
	Investment Company	A Public Company Limited by Shares, Private Company Limited by Shares or Private Company Unlimited with Shares which carries on the business of investing the pooled capital of investors in financial securities. It can be

		an Open Ended Investment Company or a Closed Ended Investment Company.
	Branch of a Foreign Company	A branch of company incorporated or formed outside of ADGM, whether under the federal or local laws of the United Arab Emirates, or the law of the country or territory who is registered and licensed to operate in ADGM.
Partnership	Limited Liability Partnership (LLP)	A partnership structure under which each partner's liability is limited to that of their interest in the partnership only (and their personal assets are therefore protected from debts or liabilities incurred by the other partners).
	Branch of Foreign LLP	A branch of an LLP incorporated or formed outside of the ADGM.
	General Partnership	An arrangement under which partners conducting a business jointly have unlimited liability, which means their personal assets are liable to the partnership's obligations.
	Branch of Foreign General Partnership	A branch of a General Partnership formed or incorporated outside of the ADGM.
	Limited Partnership	An arrangement under which two or more partners unite to jointly conduct a business in which one or more of the partners is liable only to the extent of the amount of money that partner has invested.
	Branch of Foreign Limited Partnership	A branch of a Limited Partnership formed or incorporated outside of the ADGM.
Foundation	Foundation	A foundation is a legal entity established by a founder which has its own legal personality and holds assets in its own name on behalf of beneficiaries. A foundation must be established with one or more objectives, which must be lawful.
DLT Foundation	DLT Foundation	Legal structure with its own legal personality tailored for blockchain foundations, DAOs, and Web3 entities.

Business Activities

The licensing fees charges vary depending on the category of permitted business activities which the entity carries on:

- Financial Business Activities (Category A);
- Non-Financial Business Activities (Category B);
- Retail Business Activities (Category C).

Specific fees also apply to certain entity classifications and business activities:

- **Specialised Fees** apply to:
Specialised fees are applicable to company types who carry on certain specified activities and thus are subject to different pricing than standard entities
 - Professional Membership Organisations;
 - Companies or Partnerships entering into Insurance Contracts as a Principal (Captive Insurers only);
 - Investment Partnerships;
 - General Partners of Investment Partnerships;
 - Open Ended Investment Companies;
 - Closed Ended Investment Companies; and
 - Special Purpose Vehicles.
- **Incentivised Business Fees** apply to:
Incentivised fees are granted based on specific eligibility criteria with the objective of supporting initiation and acceleration of specific sectors and business activities; incentivised fees apply for a specified duration only, after which the companies revert to paying standard entity fees of their respective category
 - Tech Start-ups;
 - Venture Capital Fund Managers (VCs);
 - Social Enterprises.

2. Incentivised Structures and Activities

2.1 Initial Registration and Annual Renewal Fees

ADGM has incentives in place to promote specific structures and business activities. The table below indicates the amount in USD payable by the applicant during licence issuance and renewal for the duration of the incentive.

2.1.1	Tech Start-up	\$ 1,500	3 Years	Incentive applies to eligible applicants for a duration of 3 years (including existing Tech Start-ups before 01 January 2025).
2.1.2	Venture Capital Fund Managers (VCs)	\$ 1,500	3 Years	Incentive applies to eligible FSRA-approved applicants for a duration of 3 years (including existing VCs before 01 January 2025).
2.1.3	Social Enterprises	\$ 700	N/A	Subject to obtaining and maintaining a certificate/ approval confirming classification of the entity as a "Social Enterprise" from the competent Authority.
2.1.4	Carried Interest Vehicle	\$ 1,900 <i>Initial Registration</i> \$ 1,000 <i>Renewal</i>	N/A	Incentive applies to eligible applicants that conduct carried interest vehicle activities.

* Incentivised Fees are only applicable during the total duration period after which entities will be charged standard applicable fees as per the schedule in Section 1. Annual Data Protection fees are excluded.

- Incentivised Fees are only applicable during the total duration period after which entities will be charged standard applicable fees as per the schedule in Section 1; where Tech startups (startups conducting non-financial activities) revert to CAT B revised fees and fintech startups (startups conducting at least one financial activity) revert to CAT A revised fees after the duration of the incentive
- Incentive for all startups and Venture Capital Fund Managers is applicable for the registration and two consecutive renewals after issuance of the licence

3. Registration of Auditors

3.1. Initial Registration Fees

Audit firms that wish to operate in ADGM must be licensed by ADGM, pay the base level auditor registration fee, and as a minimum register at least one principal subject to the below fees. Please check the eligibility criteria before applying, which can be found [here](#).

Additional Permits are required to audit public interest entities and Financial Institutions (FI), for which an additional registration and annual renewal fee shall apply.

3.2. Annual Renewal Fees

If a Registered Auditor wishes to renew their registration, they must pay an annual renewal fee. The amount of the fee payable is specified in the right-hand column of the table below and is dependent upon the number of audit reports issued in the twelve-month period of the previous calendar year.
